SCHOLARSHIP

RESEARCH SUMMARY

I strive to bring child development and parent-child family relationship theory and research to applied settings (i.e., translational science), geared toward the promotion of healthy interactions and the prevention of negative behavioral outcomes. Three current projects – an fMRI study of adults with histories of parental acceptance versus rejection, the UConn Rising Scholars program to promote educational attainment for youth in foster care, and a \$5 million federal demonstration grant to study (in a randomized control trial) the Supportive Housing for Families housing and child welfare intervention for families with children in, or at risk for, foster care, highlighted in a Congressional Briefing – exemplify my research.

I have journal manuscripts currently under review on those three topics, plus others (all with student co-authors) including child best interests standards, genetic counseling experiences, criminal behavior in youth, longitudinal effects of acceptance-rejection, foster parents' educational practices, home visitation workers' stress, and childhood trauma and allostatic load across the lifespan.

Child-Parent Relationships

I have conducted laboratory studies on samples of children and caregivers. My published studies have identified key parental caregiving approaches associated with child attachment security and the family's coping with stress/trauma (e.g., Britner, Marvin, & Pianta, 2005). These studies are based on child-parent interactions across a variety of settings, as well as interviews and questionnaire data from multiple informants, in an effort to understand the relevant child, parent, interactional, and cultural/contextual variables in the development of self-regulation and close relationships (e.g., secure attachment) and various individual characteristics (e.g., shyness, self-control). With my students, I have completed several studies of parents' "resolution" of their children's medical or mental health diagnoses (e.g., Kearney, Britner, Farrell, & Robinson, 2011). My most cited work to date is the Marvin and Britner chapter on normative development in the *Handbook of Attachment* (1st, 2nd, and 3rd ed.) with over 800 citations.

Building on prior acceptance-rejection research (e.g., Rohner & Britner, 2002), I was awarded a 2018-2019 seed grant for "Neural Correlates of Remembered Parental Rejection in Childhood" from the Brain Imaging Research Center, UConn [Preston Britner, PI; \$10,000], as well as internal departmental funding. Working with faculty colleagues and Sumbleen Ali (HDFS Ph.D. student; major advisee), we are investigating neural activity among young adults who retrospectively felt either accepted or rejected by their parents during childhood. In the context of the Cyberball paradigm, which elicits feelings of peer rejection while the participant undergoes fMRI scanning, we are probing for group differences in brain regions that critically support social pain (e.g., ACC subdivision, right precuneus, dorsomedial PFC, amygdala, TPJ, ventral striatum, and insula). This work will provide a foundation for understanding the neurobiology of remembered parental acceptance-rejection, helping researchers, clinicians, and practitioners better understand the negative developmental consequences of perceived rejection. This collaboration bridges family science and neurobiology – initiating one of the first affective neuroscience studies at UConn – and could provide needed pilot data to pursue federal funding.

Prevention Research and Evaluation

A book chapter by O’Neil and Britner (2009) was cited in the official American Psychological Association policy (2014-2020) on “Guidelines for Prevention in Psychology” in terms of best practices in training programs and with respect to key skills and competencies. This is the first time APA has endorsed prevention guidelines.

I concluded my term as the third Editor in the history of *The Journal of Primary Prevention*, an international academic outlet for papers that are relevant to prevention theory, research, and practice. I remain involved as Editor *Emeritus*. Most of the journal’s readers, contributors, and board members come from community psychology, public health, or related disciplines. I moved the journal from 4 to 6 issues per year and expanded the journal’s indexing, impact factor, and reach. I focused some of my efforts as Editor on the translation of prevention theory and research for relevant practitioners and policymakers, and – with my predecessor Martin Bloom -- initiated a practice called the “Editors’ Strategic Implications.” For each article in the journal, I wrote (sometimes in coordination with an Associate Editor) a statement of the paper’s “take home” points for identified audiences (e.g., school administrators considering a bullying prevention program; policymakers who might be interested in cost-benefit analyses on a state-run substance use prevention initiative; practitioners seeking to improve client retention in their home visitation program).

My two co-authored books are on the topic of evaluation of programs within the helping professions. I have taken many of the lessons I have learned from my editorial and evaluation research experiences into my state and federal prevention endeavors related to the systemic analysis of the effectiveness of prevention and intervention programs for children and their families. I continue to study and write on a variety of aspects of child abuse prevention.

Building on my published research on preventing child abuse through parent education, I have participated in national discussions about “what works” in parent education efforts to prevent negative outcomes and promote positive, healthy interactions and behavioral change in areas such as communication and discipline (e.g., the American Psychological Association Working Group on Child Maltreatment Prevention in Community Health Centers).

Community-based, Family-focused Approaches

Research with my colleague, Anne Farrell, and my graduate students, funded by a series of grants and research contracts, has addressed family-focused child welfare services for: 1) families struggling with mental health/substance use and reunification; 2) professional, long-term foster care for severely at-risk children; and, 3) youth and families who are homeless or at risk for being homeless. We have presented and published findings, and we intend to expand on longitudinal and mediational (using the Alpert & Britner [2009] measure of client engagement) analyses with respect to these various intervention models.

Funding (2012-2017; no cost extension through 2018) from a competitive federal demonstration grant supported the development, study, and dissemination of a model of Supportive Housing for Families. The \$5 million grant came from the Children’s Bureau, Administration for Children, Youth, and Families (ACYF), U.S. Department of Health & Human Services, to the Connecticut Department of Children and Families (including a \$1 million evaluation sub-contract to Preston Britner [PI, UConn] and Anne Farrell [PI, Chapin Hall, University of Chicago]) to expand and study the model (in a randomized control trial, with a cost-benefit analysis). <https://www.chapinhall.org/wp-content/uploads/ISHF-Report-FINAL.pdf> A 2-page brief on key findings is here: <https://www.chapinhall.org/wp-content/uploads/ISHF-Two-Page-Brief-April-2019.pdf> In April 2019, we were able to share key experimental findings at a Congressional Briefing at the U.S. Capitol and at a separate Federal Agencies Briefing for staff from relevant executive branch agencies. Of the five national sites, Connecticut was successful in stably housing families and had the largest effect size in terms of reunifying children with their families (reunification cases) and preventing removals to foster care (family preservation cases). Farrell and I (with our students) published three 2017 articles in special issues of journals devoted to family homelessness and homelessness/child welfare, and we are now in the process of submitting articles on the demonstration findings.

In my role as Co-Chair of the state's Families with Service Needs (FWSN) Advisory Board during the full span of its existence (2006-2010), I oversaw the evaluation of the Family Support Center model we developed. The model diverts at-risk status offender youth and their families out of the child welfare and juvenile justice systems and into community-based, family-focused interventions; it has been recognized as a national model by OJJDP, the Vera Institute for Justice, etc. Connecticut's efforts have resulted in the sharpest drop in juvenile detention rates in the nation, as highlighted in several national studies in 2013 and 2014.

While serving on the APA's six-member Committee on Children, Youth, and Families (2010-2012; co-chair in 2012), I edited an issue of *CYF News* on models of diversion. I continue my scholarly policy efforts with APA, as well as with NCFR and its Family Policy Section.

Youth Mentoring, Positive Youth Development, and Supportive Interventions

I have published a number of articles and book chapters, and edited a special issue of a journal, on the topic of youth mentoring (and related prevention approaches). I have collaborated with several state agency and nonprofit partners to incorporate mentoring components into their programs for various at-risk populations.

I served on the Program Advisory Board for the UConn Rising Scholars program, which brought youth in foster care to the UConn Storrs campus for a month each summer and supported them academically throughout the school year. I am advising the site on programming to promote positive outcomes (e.g., educational attainment, including high school completion and college entry and completion) among multiple cohorts of youth in foster care and helping to evaluate the success of this supportive program. With my Ph.D. student, Ciara Collins, I have published some early findings (Britner & Collins, 2018), helped secure funding for the program, led national discussions about expansion of the model across the country, and recently begun to track long-term outcomes with Nate Okpych, Ph.D., of the UConn School of Social Work. The program has operated for 7 summers to date. Bucking national trends (i.e., only 3% of youth in care graduate from 4-year colleges), 99% of seniors in the program have graduated from their high school, and over 90% have been accepted to and matriculated in colleges and universities, with a number of the students enrolled at UConn. We have begun research to study long-term outcomes of the program so as to contribute to the field (and ensure continued support).

I also served on the Services and Supports sub-committee of the state's Homeless Youth Workgroup and was part of a successful grant application that received funding from the Melville Foundation to develop a comprehensive service delivery model for runaway and homeless youth, with the goal of ending homelessness among youth and young adults in Connecticut.

TEACHING

TEACHING PHILOSOPHY

In the classroom, I emphasize the need to use scientifically sound data in order to test theories. Thus, I routinely have students actively form testable hypotheses, and then either collect data or complete a comprehensive secondary review of research literature. I also encourage students to spend a great deal of time in formulating appropriate research questions, given the complex, multivariate ecological approach needed to address most topics in the realm of human development, community psychology, education, family relations, social issues, and law/social policy. As background, it is important to introduce a topic clearly and to help students learn about the strengths and weaknesses of past research and the methodological issues involved. More active learning occurs, however, when students seek knowledge through activities, and they prepare themselves for real-world tasks like communicating their work through assignments such as presentations, papers, testimony, and court or policy briefs.

My teaching philosophy entails getting students excited about the material by "sharing" my field and my experiences with them, so that they in turn will explore areas that are valuable for their own career, educational development, and the betterment of the community. Whether I am presenting my own research or covering a topic that is rather distant from my areas of expertise, I try to bring a passion for the learning into every class session.

Good teaching starts with preparation, a strong foundation of knowledge in the area, and a cohesive game plan for the semester and each class period. I see my syllabus as a contract with the students, so I pay careful attention to crafting clear course objectives, instructor expectations, and student responsibilities, and stringent but fair evaluation criteria. I emphasize a variety of levels of thinking (e.g., Bloom's 1956 taxonomy) using a mixture of pedagogical approaches in class; thus, assignments and exams reflect students' knowledge and critical thinking. Although I always have a prepared "lecture" and research example, I also challenge students to question the research and justify their arguments in class discussions and debates. I think that it is important to strive for flexibility amidst structure -- to be able to break from a fixed path of a lecture to address questions, launch discussion, and attend to the interests and individual learning styles of the students without losing sight of the goals of the class as a whole.

I make it clear to my students and advisees that I care about teaching by showing my interest in their comments, their work, and in them as individuals, and by making myself available to them outside of class. Advising, mentoring, writing letters of recommendations (e.g., awards, grad schools, jobs), etc., are all a part of my responsibility as a teacher.

My direct mentoring of students has resulted in over 100 scholarly publications or presentations with more than 50 different undergraduate and graduate students. Most of the undergraduate thesis students I supervise go on to prestigious graduate schools. I have served as major advisor for 22 graduate student theses and dissertations and associate advisor for 46 graduate student theses and dissertations. My major advisees have won numerous university (e.g., Edward V. Gant Scholar; Outstanding Senior Women Academic Achievement Award) and national (e.g., APA Division 37, Section 1 [Child Maltreatment] Dissertation Award) awards and successfully gained research postdocs (e.g., Tufts University; University of Pennsylvania), tenure-track faculty positions (e.g., Columbia; Tufts; UConn; Yale), national policy fellowships (e.g., SRCDC Congressional Fellowship, Richman Fellowship/Chapin Hall), and influential research/policy jobs (e.g., Children's Rights, Inc.; Child Health & Development Institute).

PUBLIC ENGAGEMENT, SERVICE, AND OUTREACH

I have chaired, co-chaired, or served as a member of dozens of committees at UConn from department to university levels, assisted many state agencies, the legislature, and community partners in Connecticut, and contributed to a number of national professional service capacities. I have been recognized with the 2015 Provost's Award for Excellence in Public Engagement (tenure track faculty), the 2011 UConn AAUP Service Excellence Award, a 2010 Commendation by the University Senate (for co-chairing the months-long, cross-campus Metanoia on preventing violence against women), the 2009 Community Volunteer Organizer Leadership Award (The Chamber of Commerce, Windham), and the 2008 Award for Legislative Advocacy (Connecticut Youth Services Administration).

My UConn service roles include: member (2020, 2021, 2022; Chair, 2022) of the Faculty Review Board; Chair (2014-2016) of the Planning and Evaluation Committee, UConn's 2016 NEASC Self-Study for university accreditation; member of the (2013-2014) University Academic Vision Committee, 2014-2020 Academic Plan; the (2012-2013; 2019-2020) Chair of the Faculty Standards Committee (and member: 2012-present), University Senate; a member (2009-2010; 2011-2013) of the Executive Committee, AAUP, UConn Chapter; Co-Chair (2008-2012) of the Public Engagement Forum, UConn (and the lead author of UConn's successful 2010 Carnegie Foundation "Community Engagement" classification application); Chair (2008-2010; 2012), Advisory Board, Institute for Teaching and Learning; and, Associate Department Head for Graduate Studies (2006-2010; 2019-2023) for HDFS.

I helped create the UConn Rising Scholars program, which brings youth in foster care to the UConn Storrs campus for a month each summer and supports them academically throughout the school year. Bucking national trends (i.e., only 3% of youth in care graduate from 4-year colleges), 99% of the seniors who have completed the program [over 7 summers (2013-2019)] have graduated from high school and over 90% have been accepted to and matriculated in colleges and universities, with a number of the students enrolled at UConn.

At the state level, I have served on a number of boards related to improving child welfare practices. I was the Co-Chair of Connecticut's Families with Service Needs (FWSN) Advisory Board (2006-2010), overseeing the creation and evaluation of the Family Support Center model to divert at-risk status offender youth and their families out of the child welfare and juvenile justice systems and into community-based, family-focused interventions. It has been recognized as a national model by OJJDP, the Vera Institute for Justice, etc., as Connecticut had the sharpest drop in juvenile detention rates in the U.S., highlighted in several national studies in 2013-2014. I have also regularly testified at the General Assembly related to matters involving child welfare, including the integration of housing and child welfare services for families of youth in state care.

In terms of national and international professional service, I served from 2004-2009 as the Editor of *The Journal of Primary Prevention*, an international academic outlet for papers that are relevant to prevention theory, research, and practice. I moved the journal from 4 to 6 issues per year and expanded the journal's indexing, impact factor, and reach, and initiated a practice called the "Editors' Strategic Implications". I currently serve on four editorial boards and routinely complete a large number of additional reviews for journals, conferences, grant programs, and faculty promotions. Among other national committees, I served on APA's six-member Committee on Children, Youth, and Families (2010-2012; co-chair in 2012) and APA's 2009 Working Group on Child Maltreatment Prevention in Community Health Centers. I have

regularly contributed (e.g., Congressional briefings, policy statements, briefing memos) to national policy discussions related to child welfare practices.
